## The Healthcare Environment

**Roshtov** recognizes the need to provide the medical community with a competitive advantage. Physicians are focusing on increasing patient volume with the need to contain cost. Increases in the cost of healthcare and political pressures due to reforms are now reshaping the healthcare industry worldwide. Providers of healthcare are now required to assume the risk of cost of care, as employers and individuals are free to choose their health plan. Thus, health care providers must constantly walk the thin line between effective control of ever growing expenses and providing the best medicine professionally possible.

### Administrative costs

According to research, about 15% to 30% of patient charts are misplaced or lost, or on the other hand duplicated. Lack of central access to a patient record results in delayed or erroneous billing, duplication of effort, or even increased liability due to potential mistakes or fraud.

### Improving quality of care and lowering costs

More than 70% of the health care budget is controlled by physician decisions. This is where the major potential savings in the cost of healthcare reside. Influencing physician practices has been difficult because of the need to provide feedback to the physician while decisions are made. For these reasons, medical management is now, focused on two main areas important in responding to competition: productivity (increased volume of patients seen with same or less resources), and patient satisfaction (to maintain their patient base).

Consistent record keeping, in managed care organizations, enables quick assimilation of medical data by multiple doctors dealing with a patient's file. Moreover, capturing medical data at the point of care, and accessing it where and when needed, is essential to making accurate, well informed decisions and providing quality care. Reducing the amount of time spent on paperwork and quickly producing all documentation, whether as a function of patient care or as support for claims and decision-making, is imperative.
